4. Make a diligent commitment to participate actively in committee work.
5. Stays informed about committee matters, is prepared for meetings, and reviews and comments on minutes and reports.
6. Builds a working relationship with other committee members.
7. Participates in annual evaluation and planning efforts.
8. Participates in the advancement of the strategic plan including fundraising and member recruitment.
